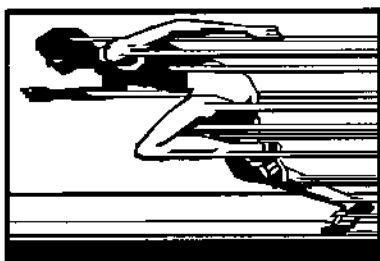

REGISTRATION & PACKET PICK-UP: Begins at 7:00 am and closes at 8:45 am at the Danville Community Center. From Dardanelle, take Hwy 27 South to Danville and watch for signs.

**COURSE:** Flat at mile 1 & 2 with a few rolling hills between the 1/2 mile marker; 1 water stop.

**T-SHIRTS:** All entrants will receive a T-shirt!

**KIDS RUN:** K-6th, Male & Female. All finishers of the kids run will receive an award.

**5K AWARDS:** Top 3 OVERALL, Male & Female, Top 3 in 5 year age division (10 thru 70, Male & Female)

**WALKERS:** This is a non-competitive event.

**AWARDS:** will be inside the main building after the race ASAP.

**RUNNERS:** 3 Deep 5 year age division Male & Female:  
1-5, 6-9, 10-14, 15-19, 20-24, 25-29, 30-34, 35-39, etc. to 70 & over.  
Overall: 1-3, Male & Female  
Masters: 1-3, Male & Female
